## WILL YOU STEP FORWARD AND BE A VOICE FOR FOSTER PARENTS?

HB 1624 UPDATE

The 1624 Committee has been renamed the Children Administration Foster Parent Consultation Team (CAFPT) with a new charter approved in July of 2011. The mission statement remains the same. *“Strive to improve the well being and protection of all children in foster & relative care and to enhance and strengthen services for children and caregivers in the Washington”*. The purpose is: *Work together to enhance and strengthen services for the protection of children, and Work together to improve recruitment and retention of foster parents and continue to provide enhanced training that meets the needs of foster parents and relative caregivers.*

Region 3 North (previously known as Region 5) has two foster parent representative positions on this important committee. The positions are voluntary. There is no stipend or mileage. The duties require about two days a month and include meetings, teleconferences, videoconferences and communicating via email.

The other position is vacant. **Nominations can be made to TOM STOKES at [tom.stokes@dshs.wa.gov](mailto:tom.stokes@dshs.wa.gov) or by contacting Elizabeth who will forward the nomination to Tom.** Qualifications for the position include experience as a foster parent and current licensure.

This committee reviews and takes forward to the State a range of issues that impact foster and relative care. All caregivers are cordially invited to submit issues directly to the representatives or take them in person to the Regional Recruitment and Development Strategy (RDS) meetings.

## IMMUNIZATION FAQs

**What are the immunization requirements for foster parents' own children?**

In order to be licensed for 0-2, the foster parent's children must have immunizations as recommended by the Center for Disease Control's Advisory Committee on Immunization Practices, with the exception of the Rotavirus vaccine which must be given at a specific age.

In order to be licensed for 2-18, the children must have immunizations as recommended by the ACIP, with the exception of the Rotavirus vaccine which must be given at a specific age. The department may grant an exception to this requirement if the family has a physician's statement indicating that a valid medical reason exists for not obtaining immunizations for the child.

**Are there any exceptions to this requirement?**

If the family is licensed specifically to care for a related child and that child's family agrees to placement in an under immunized home, or if the family's physician sends CA a letter indicating that the children have necessary immunizations to reduce the risk of infection to children under the age of 2 that the immunizations are intended to address AND we have a written compliance plan approved by the physician with the schedule for the continued immunization of the children to get them caught up and keep them on schedule with future immunizations.

**Why does CA require that foster families immunize their own children?**

Exposure to unimmunized children increases the health risk to vulnerable children in our care.

Washington's Department of Health and the Children's Administration's medical consultants supports this requirement, based on that risk.

**What legal authority does CA have to impose this requirement?**

Washington Administrative Code 388-148-0525 authorizes the department to restrict the age range of children a foster home is licensed to serve. This is based in part upon the "... age of the foster and birth applicant or licensee's children and the physical and emotional condition of the children...."

**What if the family was licensed before CA restricted placements based on their children's immunizations?**

CA began restricting the age range based on immunizations in 2009. Licenses due for renewals are examined with this restriction in mind. Children currently in care with a foster family do not need to be moved based upon the immunization status of the family's own children. Adjust the license age range and engage the placement desk as well as the foster family in limiting new placements.
